Deworming Small Ruminants and Camelids

When to deworm? What product? How often should I be deworming? These are common questions and concerns with owners that usually spark a good discussion on parasite management. Internal parasites in goats, sheep, alpacas and llamas are a major concern. The hard part is finding a balance between deworming the animals that need it while also maintaining refugia. Refugia may be a new term for some people, the idea is to maintain a population of worms that are susceptible to the deworming products that we use. Parasite resistance is becoming more and more of an issue. To attempt to slow development of resistance we need to use two management techniques to determine WHO should be dewormed:

FAMACHA

The FAMACHA scoring system is used to find animals affected by the barberpole worm, Haemonchus contortus. This worm sucks blood and causes anemia, or low red blood cell counts, in animala which then leads to decreased activity and energy. The FAMACHA score is based off of the color of the mucous membranes – bright pink-red is a healthy animal whereas white means a severely anemic and sick animal. Our veterinarians are trained in the FAMACHA scoring method and it is a quick screening tool for your whole herd.

1. Fecal egg counts

This method monitors for other internal parasites that do not suck blood but also cause sick animals. Besides being able to determine which type of parasite eggs are present, this method also allows you to see how much of a parasite load is present in the individual animal. Another benefit is that we can repeat the FEC 14 days after deworming to see if that particular dewormer is effective.

Choosing the deworming product ideally is based upon the history of the farm and efficacy of that product (proven with FEC). Rotating between products will speed up the development of parasite resistance so one dewormer should be used until it no longer works – based on FECs, FAMACHA scoring, and clinical signs. The best time to deworm is in the spring as the parasite eggs hatch and infect young animals or reinfect the herd and also in the fall once the ground freezes. Giving the correct amount of dewormer is also important so determining each animal's weight is ideal.



The easiest way to do this for small ruminants is show in this picture:



Keeping a record of an individual animal's age, weight, FAMACHA score, and FEC helps to monitor changes in each animal over time and catch any resistance or problems early.

Deworming program with veterinarian: minimum 1 fecal egg count, 2 deworming administrations (praziquantel and moxidectin or 5 day double dose fenbendazole)
Horses with a history of 3+ colic episodes in 12 months prior to enrollment must be colic free for 12 months before reimbursement
Horses with a history of 1 colic surgery have lifetime maximum of \$2500 in months 13-24m so long as the first 12 months are colic-free.

Eligibility

Horse must reside in U.S. and be under direct care of licensed veterinarian, be at least 5 months old and fully weaned Ineligible if: any previous colic or abdominal surgery, history of chronic colic (3+ within any 12 month period), experienced a colic episode in the 12 months prior

SmartPak can revise or cancel this program with 90 days notice to customer.

Eligibility

Horse must reside in U.S. and be under direct care of licensed veterinarian, be at least 5 months old and fully weaned Ineligible if: any previous colic or abdominal surgery, history of chronic colic (3+ veterinarian-attended colic within any 12 month period), a colic episode in the 12 months prior to applying

\$8,000 coverage: Platinum Performance Equine or Platinum Performance CJ

\$10,000 coverage: Platinum Performance GI, PP Equine and Platinum Balance, PP Equine and Platinum Gastric Support, PP CJ and Platinum Gastric Support

Product must have been fed for at least 28 days prior to surgery and for the entire time since acceptance

Eligibility

Horse must reside in U.S. and be under direct care of licensed veterinarian, be at least 5 months old and fully weaned

Ineligible if: more than one abdominal surgery, attending veterinarian can't rule out other causes of colic other than digestive, either a presumptive or confirmed diagnosis of lipomas or enterolithiasis, or is a miniature horse, donkey, burro, mule, zebra, or zorse

Any qualified horse that has 3+ colic episodes while enrolled will no longer be eligible for benefits

Qualifying products: Assure Guard, Assure Plus, or Assure Guard Gold

Product must have been fed for the loading period and all consecutive calendar days since
